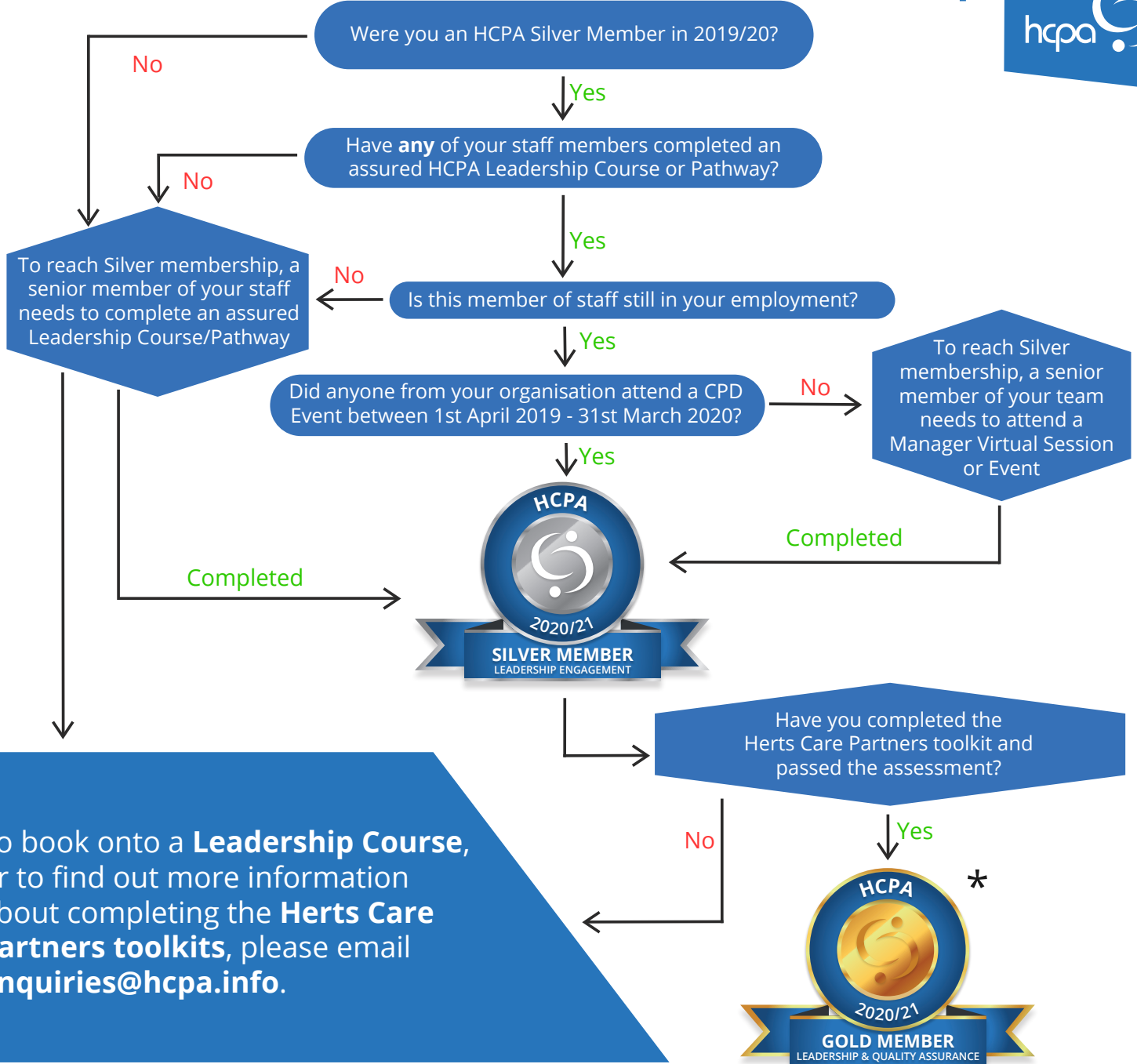
## Who can be an HCPA Member?
